VOLUNTARY CHOICE

Rather, they are recreational activities in which I am voluntarily participating for my own enjoyment.

I hereby grant permission to the RELEASED PARTIES to film, videotape and record me, free of charge, as it relates to my attendance at and participation in the Event, and I acknowledge and agree that the RELEASED PARTIES and their representatives shall have the unlimited right throughout the universe to copyright, use, reuse, publish, republish, broadcast and otherwise distribute all or any portion of the Event in which I may appear on any and all radio, network, cable and local television programs and in any print materials and in any o ther format or media (including electronic media) no known or hereinafter devised in perpetuity without compensation and free of charge.
